A correlation will be established between this COMPETENTIAL MAP of CONTRUCTIV and the result of the TRAINING MAP carried out by LIMERICK, a correspondence between the professional competences and the related training actions.

MEMORANDUM

Current Status: First of all the members introduced themselves, as new staff have joined the partners of CONSTRUCTIV and LIMERICK. Regarding the first ones, in addition to Kristof and Willen, Jean-Yves joined the videoconference. As for the second ones, in addition to Seamus, we also had Mark in attendance.

As we have some delay in the implementation of WP2, it was the main reason for discussion among the consortium members. There is a concern about having a framework of action where both CONTRUCTIV and UNIVERSITY OF LIMERICK can work together. Since the objective is to create a map of competencies and training, the two partners have many synergies and need to know the research framework to focus their efforts and energies. The project coordinator, FORTEC, will make every effort to clarify as much as possible the target within the construction sector, where we will focus our efforts, although, at the same time, each member's own research within a general framework of the European construction sector, through secondary sources, should help to focus their efforts.... On the other hand, we are once again checking the efficiency and technical solvency of both members of the consortium in carrying out these tasks.

1. Monitoring meeting issues

- Final list Countries: we finally decide 12 countries
- Stakeholders: Every partner has to identify their stakeholders from Industry, Trade Unions, Education Entities, etc. We have confirmation by CONTRUCTIV that they have real contacts with FIEC (European Construction Industry Federation) and with EFBWW (European Federation of building Industry and Wood Workers). On the other hand, FORTEC has the confirmation that AEEBC (Association of European Experts in Building and Construction) is willing to be involved in our project. We recommend that the members of the consortium seek out partners who are umbrella organisations within the vocational training and construction sector, such as UNIEP, GCI-UICP, The Bulgarian Construction Chamber (BCC), CICA, European Builders Confederation, European Federation for Construction Chemicals, CECE, etc...
- Research Methodology: Clarification on the sampling sizes The consortium is simply informed of this point in order to resolve it with the Executive Agency and that it concerns WP2, which is so relevant at the moment. FORTEC will develop this point

 Description of planned expert review. We have informed the consortium that we have already made a plan for the quality of the deliverables and the reports of project results, in order to be able to agree with them.

- <u>Dissemination Plan</u>. We have already made a Dissemination Plan Model. We have decided that the most suitable FORMS to share information about the activities for every single Dissemination Plan should be number 5 and number 8.

We have discussed about the IPR, the relevance of this matter and which should be the best way to exploit the Detecta Tool. We are very concerned this should be taken very carefully and try to choose the right model for every partner of the consortium.

Once we finish the Dissemination Plan with all the activities of the consortium, we are sure to know the real impact and numerical indicators. On the other hand, we are looking for more stakeholders to disseminate the project.
- Clarification on the proposal to revise the over-complex project management structure. We have decided to simplify the project management and direction structure, through a horizontal structure of project managers from each partner, starting from the origin of the information from the Executive Agency and from FORTEC, as coordinator.
